TERMS AND CONDITIONS

The completed, signed and dated booking form (overleaf) and these terms (including any incorporated terms), form a legally binding contract (Agreement) between the company or person named on the Form (Client or you) and Brisbane Bullets ABN 66 608 193 497. This Agreement sets out the terms on which the Client will acquire, and Brisbane Bullets will supply, the Brisbane Bullets Corporate Hospitality Package.

1. Bullets Hospitality Package

In this Agreement the Brisbane Bullets Corporate Hospitality Package means the hospitality package supplied by Brisbane Bullets to the Client on each match day, which includes admission to a game, the supply of a ticket and other benefits as noted by Brisbane Bullets.

2. Payment

2.1 Payment is to be made as per the chosen payment option.

2.2 Payment is immediately due and payable upon submission of a completed, signed and dated Corporate Hospitality Booking Form.

3. Cancellation

3.1 All cancellations must be in writing.

3.2 If the purchase of the Brisbane Bullets Corporate Hospitality Package is cancelled by the Client 7 or more days prior to the relevant game, the following refund policy will apply:

- a) 100% refund of payments should the Brisbane Bullets Corporate Hospitality Package be on sold by Brisbane Bullets; or
- b) 50% refund of payment should the Brisbane Bullets be unable to on sell the Brisbane Bullets Corporate Hospitality Package, despite reasonable efforts of Brisbane Bullets to on sell the package.

3.3 If the purchase of the Brisbane Bullets Corporate Hospitality Package is cancelled less than 7 days prior to the relevant game, the Client will not be entitled to a refund.

3.4 Brisbane Bullets may cancel the Brisbane Bullets Corporate Hospitality Package without notice if you are in material breach of any provision of the Agreement.

3.5 Brisbane Bullets will not be liable for any loss or damage arising out of the cancellation of the Brisbane Bullets Corporate Hospitality Package pursuant to clause 3.4.

4. Indemnity

4.1 The Client will indemnify Brisbane Bullets against any loss or property damage arising out of the Client's use of the Brisbane Bullets Corporate Hospitality Package and for any personal injury, death or loss or damage to any property or any person arising out of or as a consequence of your use of the facility or services except where such loss, damage, injury or death arises from negligent act or the omission of Brisbane Bullets.

5. Distribution of the Hospitality Package

5.1 Brisbane Bullets will distribute tickets, hospitality passes (if required) and other information to the Client approximately 14 days prior to the relevant game provided full payment has been received. Season Corporate Hospitality holders will receive their hospitality passes and relevant information approximately 2 weeks prior to the season start unless ordered within this period at which time Brisbane Bullets will provide an alternate distribution method.

6. General Conditions

6.1 Client must ensure that each of its guests and ticket holders:

- (a) does not act inappropriately (for example by making undue noise, being intoxicated, causing a disturbance or behaving in an offensive manner), as determined by Brisbane Bullets in its sole discretion, at Brisbane Bullets venues;
- (b) do not erect, fix or display any goods, materials, advertisements or promotional material in, on or around the game day facility, without the prior written consent of Brisbane Bullets;
- (c) comply with all reasonable directions given by Brisbane Bullets and the game day facility from time to time (and obligations referred to in the Privacy clause below);
- (d) comply with all ticket conditions specified on tickets issued as part of the Brisbane Bullets Corporate Hospitality Package; and
- (e) do not use the Brisbane Bullets Corporate Hospitality Package for any purpose other than that for which it was sold. Without limiting the generality of the foregoing, it is a condition of sale that any Brisbane Bullets Corporate Hospitality Package or part thereof will not be re-sold, on sold, sublet or rehired nor used for advertising, promotion or other commercial purposes (including competitions or trade promotions) or to enhance the demand for other goods or services, without the prior written consent of Brisbane Bullets.

6.2 Any breach of this clause may result in the ticket holders being evicted from the Brisbane Bullets venue and may result in the cancellation of the existing Brisbane Bullets Corporate Hospitality Package without a refund, as decided by the Brisbane Bullets in its absolute discretion.

7. Privacy

7.1 In providing the Brisbane Bullets Corporate Hospitality Package under this Agreement, Brisbane Bullets complies with the NBL's Privacy Policy (Privacy Policy), available at http://nblclubstatic.s3.amazonaws.com/NBL_Privacy_Policy.pdf, as if references to the NBL were references to Brisbane Bullets.

7.2 The Brisbane Bullets may seek and collect personal information, including sensitive information (as those terms are defined in the Privacy Act 1988 (Cth)) from the Client about the Client and its guests and ticket holders in accordance with the Privacy Policy.

7.2 Use of personal information

(a) Brisbane Bullets may use and disclose personal information for the purposes set out in the Privacy Policy.

(b) The Client may request its personal information, and the personal information of its guests and ticket holders not be disclosed or used for promotional purposes by opting out at the time of submitting a completed Corporate Hospitality Booking Form, or the Client, its guest or ticket holder can notify Brisbane Bullets in writing at the address below.
